RESOLUTION NO 2 OF 2007

AMENDMENT TO RESOLUTION 1 OF 2007

Noting that:

1. Clause 4.17 of Resolution 1 of 2007 states that "The revised salary structure for occupations to be implemented with effect from 1 July 2007 shall be finalized in the relevant sectoral bargaining councils by no later than 31 July 2007. In the event that the negotiations process is not concluded by 31 July 2007, the matter shall be referred to the PSCBC for finalization within 7 days of the expiry of 31 July 2007".
2. Sectoral bargaining councils are in a process finalizing the revised salary structure for the occupations.

Scope

This agreement binds,

- (a) the employer,
- (b) the employees of the employer who are members of the trade union parties to this agreement; and
- (c) the employees of the employer who are not members of any trade union parties to this agreement, but who fall within the registered scope of Council.

Agreement

3. Therefore the Council resolves to extend the period 31 July 2007 as stipulate in Clause 4.17 of Resolution 1 of 2007 as follows:
 - PHSDBC to finalize the occupation specific salary structure for all categories of nurses by 15 September 2007 and
 - GPSSBC to finalize the occupation specific salary structure for legal professions within the justice cluster by 30 October 2007.



Dispute Resolution


5. If there is a dispute about the interpretation or application of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.




