

RESOLUTION / OF 2016

**AGREEMENT ON THE AMENDMENT OF PSCBC RESOLUTION 9 OF 1998:
DESIGNATION OF THE HEALTH SECTOR FOR ESTABLISHMENT OF A BARGAINING
COUNCIL**

1. SCOPE

1.1. This agreement binds the Employer and Employees who:

- 1.1.1. Are employed by the State; and
- 1.1.2. Fall within the registered scope of the Council.

2. NOTING

- 2.1. Section 37(1) (a) of the Labour Relations Act no 66 of 1995, as amended allows for the Council to designate a sector of the public service for the establishment of a bargaining council;
- 2.2. Section 37(1) (b) allows for the Council by resolution and in terms of its Constitution to vary the designation of, amalgamate or disestablish bargaining councils so established;
- 2.3. Clause 22 of the Constitution of Council allows for the variation, designation or amalgamation of sectoral councils; and
- 2.4. Section 37(4) requires an agreement designating, amalgamating, varying the designation must accompany any such application to the Registrar of Labour Relations.

3. PURPOSE

The purpose of this agreement is to-

- 3.1. To amend clause 4(c) of PSCBC Resolution 9 of 1998 in amending and adding of occupational definitions to schedule 1 of PSCBC Resolution 9 of 1998.

4. AGREEMENT

4.1. Parties therefore agree:

4.1.1. The occupational category of Community Liaison Officer be deleted from the occupational categories listed in schedule 1;

4.1.2. The following occupational categories be added to the list of occupational categories listed in schedule 1;

4.1.2.1. Community Development Practitioner; and

4.1.2.2. Assistant Community Development Practitioner.

5. DISPUTE RESOLUTION

If there is a dispute about the interpretation or application of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.


6. IMPLEMENTATION OF AGREEMENT

6.1. This agreement shall come into effect on the date it enjoys majority support and will remain in force unless terminated or amended by agreement.

6.2. The Council will monitor the implementation of this agreement.



